Events: 200 IM, 50 Freestyle, 100 Breaststroke, 400 Freestyle, 50 Backstroke, 100 Butterfly, 200 Backstroke, 50 Breaststroke, 100 Freestyle, 200 Breaststroke, 50 Fly, 100 Backstroke, 200 Freestyle and 1500 Freestyle.

CONDITIONS OF ENTRY

1. Swimmers must be registered two (2) weeks before the gala i.e. before the 31st December 2016.
2. **Closing date for entries 18h00, Monday, 6th of February 2017.**
3. Swimmers' entry fee – R10.00 gala entry fee, plus R20.00 per event. Programs will be available at R25 per program.
4. Scratching and No Shows after managers meeting and/or without a Doctors' note on the day of the gala, are subject to a R50.00 penalty fee per swimmer per event.
5. Late entries will only be accepted on the condition that there are lanes available and at 10 times the original entry fee i.e. R200 per late entry. Late entries close 30 minutes before the gala starts i.e. late entries closing time is 8:30am.

NOTES

- All entries to be submitted by the clubs to UDA's Records Officer via email (recordsuda@gmail.com), together with a list of their officials, on or before the 9th January 2017 at 18h00.
- Entry fees must be paid directly to clubs as applicable. Clubs to make bulk payment to UDA.
- No entries will be processed without proof of payment. Swimmer entry concessions applicable.
- Entries will be forwarded to the clubs for checking and last changes.
- uThungulu District Aquatics reserves the right to cancel/postpone the meet should there be insufficient entries.

GENERAL RULES

- The swimmers age is determined by their age on the day of the meet. The meet will be run in accordance with KZNA, SSA & FINA Age Group Rules. The one start rule will be in effect.
- Objections must be submitted in writing, by the respective clubs Team Manager, with a R300.00 fee. The Tournament Committee decision will be final.
- We acknowledge the rules provided by KZNA with regard to Clubs providing officials for the gala. However, since we are a small district those rules would not allow the UDA to host the gala professionally. We therefore require the participating clubs to together provide sufficient officials required to successfully run the meet. The number of officials required from each club will be shared out in proportion to the number of swimmers participating from each club. No entries will be actioned unless the required officials' names are submitted with the entries. Should the officials' names be given after the closing date for entries, it will be treated as a late entry and charged out as such.
